## Contract & Health Limited Warranty

This agreement is between Cooper's Ridge Labradoodles (Seller) and \_\_\_\_\_ (Buyer).

It is agreed between Seller and Buyer as follows:

### 1. DESCRIPTION OF DOG

The dog sold pursuant to the terms of this agreement is as follows:

\*Cooper's Ridge requires a signed Spay/Neuter Contract before delivery to buyer (except for the sale of breeding Labradoodles). Failure to comply with the Spay/Neuter Contract will void the H&W Contract and result in further actions to take place. While the Cooper's Ridge Litter is Registered with the ALAA the ALAA Puppy Registration will not be released until a certificate of spay/neuter by a licensed Veterinarian is issued.

### 2. CONDITIONS OF SALE

Seller guarantees that at the time of delivery, the dog is in good health. Should the dog be found to be in poor health of a serious nature, Seller will provide Buyer with a replacement dog from another litter after the dog is returned to Seller at Buyers expense or a full refund of the purchase price of the dog. Shipping and other related fees will not be refunded.

The following conditions apply to the sale of the aforementioned dog:

1. The Buyer has five (5) days from the time of receipt of dog to have the dog examined by a Doctor of Veterinary Medicine. Any request to return the dog to the Seller for a full refund must be made within this time period and may only be requested should the dog prove to be sick upon arrival. Proof of examination must be provided to the Seller. This guarantee will be terminated immediately if the dog is not examined within the allotted time.
2. A warranty against all serious life altering genetic disease is provided for two years after the date of birth. Should a confirmed genetic disease be discovered during this time that will greatly shorten the life of, or greatly alter the dogs quality of life, seller will:

A) If the dog is kept by the buyer the seller will either:

1. Reimburse Buyer the approved veterinary costs up to 1/2 the original purchase price of the dog.
2. Provide the Buyer an additional puppy for \$1,300.00 from an agreed upon Cooper's Ridge litter with an availability.

B) If the dog is returned to the seller by the buyer we will replace the dog (if any of the above mentioned occurs) with a dog from an agreed upon Cooper's Ridge litter with an availability. This will be done at no charge other than shipping.

Two independent approved veterinary examinations and reviews must be provided to the Seller documenting the genetic health issue. Reimbursement of veterinary fees will only occur upon receipt to seller of full medical report and paid buyer bills. Reimbursement will only be for expenses directly related to the treatment of the genetic disease or condition. Seller will not be responsible for any disease or condition caused by or the results of environmental conditions or negligence.

C. The Temperament & Training shall be understood by the Buyer that all puppies exhibit certain undesirable behaviors (nipping, chewing, barking, marking, etc). Buyer assumes all responsibilities for appropriate training to teach acceptable behaviors, and is responsible for proper socialization of the puppy. Buyer agrees to start providing obedience no later than 16 weeks of age and to continue with such training as long as necessary to establish a good foundation. Seller does not claim to be an animal behaviorist or a professional trainer.

4. Buyer agrees to give Seller first right of refusal to have dog returned to Seller, or allow Seller to re-home dog should it become necessary at any point during its life. Seller will pay Buyer 1/2 the purchase price once the dog is returned to Seller at the Buyers expense. The Seller may also have the option to negotiate a price for the Buyer with the new family where the dog is to be re-homed.
5. Under no circumstances shall the Seller be liable to the Buyer or to any third party for any consequential, incidental or special damages resulting from or in any manner related to the dog.
6. Upon execution of this contract all veterinary care and its associated costs are to be the sole and exclusive responsibility of the Buyer.

### 3. MAINTENANCE

Buyer agrees to maintain this dog in good health, provide routine preventative care including, but not limited to, inoculation, internal and external parasites, and preventative medication. Veterinary records must be provided to breeder if requesting refund or replacement. \*\* Buyer agrees to proper nutritional standards (such as Lifes Abundance Dog Food). If any of the above preventative care has not been provided, the health warranty will be void.

### 4. FULL AND FINAL AGREEMENT

The parties agree that this writing represents the entire Agreement between them and that no other representations have been made regarding the dog described above.

➔ Agreement must be signed / dated by Veterinarian upon completion of wellness check. Should any part of the contract be found to be illegal or invalid or unenforceable in a court of law in the state of Mississippi, the entirety of this contract is to remain valid and enforceable.
